END USER LICENSE AGREEMENT

BravoEd Inc. provides a dental event and peer-to-peer Q&A posting platform through our website BravoEd.com (the 'Site') and our application BravoEd DDS for mobile devices—iPhones, iPads and Android devices (the 'App') and provides access to collective content (the 'Content') through the Site and App (the 'Services').

By downloading and using the BravoEd DDS application (the "App") as a member and by clicking on the "Agree" or "I Accept" buttons for any submissions, or accessing or using the Site, Services, or App you acknowledge and agree to the provisions of the Terms & Conditions and affirm that the Privacy Policy forms a part of these Terms. Please carefully read the Terms & Conditions and Privacy Policy herein.

This is the legal agreement between You and BravoEd Inc. only and the App is licensed, not sold, to You for use only under the terms of this Agreement.

- 1. Scope of License.** Subject to your compliance with the terms and conditions of this Agreement, BravoEd grants You a personal, non-transferable, royalty-free, revocable, non-exclusive limited right and license ("license") to install and use the App on a mobile device ("Device"). The terms of this Agreement will govern any upgrades and new versions ("Updates") provided by BravoEd that replace and/or supplement the original App, unless such Update is accompanied by a separate license agreement, in which case the terms of that license agreement will govern. You will not use, copy, adapt, modify, distribute, license, sell, transfer, publicly display, publicly perform, transmit, stream, broadcast or otherwise exploit the Site, Services, App or Collective Content, except as expressly permitted in these Terms or expressly permitted by applicable copyright laws. No licenses or rights are granted to you by implication or otherwise under any intellectual property rights owned or controlled by BravoEd Inc. or its licensors, except for the licenses and rights expressly granted in these Terms.
- 2. User Content License.** BravoEd may, in our sole discretion, permit Registered Users to upload, submit, or transmit Registered User Content. By making available any Registered User Content on or through the Site, Services, or App, you hereby grant to BravoEd Inc. a worldwide, irrevocable, perpetual, non-exclusive, transferable, royalty-free license, with the right to sublicense (through several tiers), to use, reproduce, view, communicate to the public by any means, print, copy (whether onto hard disk or other media), edit, translate, perform and display (publicly or otherwise), distribute, redistribute, modify, adapt, make, sell, offer to sell, transmit, license, transfer, stream, broadcast, create derivative works from, and otherwise use and exploit such Registered User Content only on, through or by means of the Site, Services or App or by sublicense to partner or affiliate publications. BravoEd Inc. does not claim any ownership rights in any Registered User Content and nothing in these Terms will be deemed to restrict any rights that you may have to use and exploit any Registered User Content.

3. **Trade-marks.** BravoEd and Marker Design used in the App and on the Site are the trade-marks of BravoEd Inc. You are not granted any right or license to use the trade-marks under this agreement.
4. **Consent to the Collection and Use of Technical Data.** You agree that BravoEd may collect and use technical data, including but not limited to Your IP address and technical information about Your Device, operating system and browser, to improve Your user experience and facilitate the provision of software updates, product support and other services to You (if any) related to the App. BravoEd may use this information, as long as it is in a form that does not personally identify You, to improve its products.
5. **Registration.** To register, you must provide a username, your email address, and password specified in the registration form ("Registration Data") and have the option to enter your Title, Location and Your Picture in Account Settings. You represent and warrant: (i) the Registration Data that you provide about yourself is true, accurate, current, and complete; (ii) you are at least 18 years of age; and (iii) you will maintain and promptly update the Registration Data to keep it at all times true, accurate, current, and complete. You authorize BravoEd Inc, in its sole discretion to confirm the truthfulness and accuracy of the Registration Data. If you provide any information that is untrue, inaccurate, not current or incomplete, or if BravoEd Inc. has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, BravoEd Inc. has the right to suspend or terminate your Account and refuse any and all current or future use of the Services. By using the Services, you represent and warrant that you have the right, authority, and capacity to agree to and abide by these Terms and that you are not prohibited from using the Services. You understand that your use of the Services may involve or require the transmission of significant amounts of data. You are solely responsible for all data charges that may be charged by your wireless carrier or internet service provider or that may otherwise arise from your use of the Services. You understand and agree that the Services may include certain communications from BravoEd Inc. and affiliates, such as notifications to voluntarily provide comments and feedback on user questions posted to the App or service announcements and administrative messages, and that while these communications are considered part of BravoEd DDS membership, you will be able to opt out of receiving them. However, you will not be able to opt out of any announcements and messages related to the implementation of BravoEd's Privacy Policy and your obligations thereunder with regard to your Registered User Content.
6. **Consent to Collection and Use of Information.** You agree that if You submit an event or question using the App or Site, BravoEd will collect and use Your account information solely for the purposes of allowing You to upload information to BravoEd for review and posting using this App. This information will be handled by BravoEd in accordance with BravoEd's Privacy Policy. You acknowledge that it is Your responsibility to maintain the security of Your device.
7. **Subscription or usage fees.** BravoEd Inc. does not currently charge fees for the use of the Services. However, you acknowledge and agree that BravoEd Inc. reserves the right, in its sole discretion, to charge you for and collect fees from you for the use of the Services and to send and receive communications. BravoEd Inc. will provide notice of any fee collection via the Services prior to implementing such a fee, and you will have a choice at that time to continue to use the Services or not. If you choose not to pay, BravoEd Inc. reserves the right to immediately terminate your access to the Services.
8. **Termination.** The license is effective until terminated by You or BravoEd. You may terminate this license at any time by deleting the App from Your Device. Your rights under this license will terminate automatically

without notice from BravoEd if You fail to comply with any term(s) of this Agreement. BravoEd may terminate this license at any time and for any reason with or without notice to You. Upon termination of the license, You shall cease all use of the App, and destroy all copies, full or partial.

9. **Services; Third Party Materials.** The App may enable access to BravoEd services and web sites (collectively and individually, "Services"). Use of the Services may require Internet access and that You be bound by additional terms of service. Certain Services may display, include or make available content, data, information, applications or materials from third parties ("Third Party Materials") or provide links to certain third party web sites. By using the Services, You acknowledge and agree that BravoEd is not responsible for examining or evaluating the content, accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality or any other aspect of such Third Party Materials or web sites. BravoEd does not warrant or endorse and does not assume and will not have any liability or responsibility to You or any other person for any third-party Services, Third Party Materials or web sites, or for any other materials, products, or services of third parties. Third Party Materials and links to other web sites are provided solely as a convenience to You. Neither BravoEd, nor any of its content providers, guarantees the availability, accuracy, completeness, reliability, or timeliness of the information displayed by any Services.
10. **Security.** The Services are designed to require users to provide a valid, working e-mail address and password to access and use the Site, Services, App, and Collective Content. Upon registering, you will select a password. Your email address and the password and codes assigned to you are, collectively, your "User Information." You are solely responsible for (1) maintaining the strict confidentiality of your User Information, (2) not allowing another person to use your User Information to access the Services, (3) any and all damages or losses that may be incurred or suffered as a result of any activities that occur under your User Information. You agree to immediately notify BravoEd Inc. in writing by email of any unauthorized use of your User Information or any other breach of security. BravoEd Inc. is not and shall not be liable for any harm arising from or relating to the theft of your User Information, your disclosure of your User Information, or the use of your User Information by another person or entity. Any attempt to obtain unauthorized access or to exceed authorized access to the Site, Services, App, or Collective Content shall be considered a trespass and computer fraud and abuse, punishable under national, provincial, state, and federal laws. BravoEd Inc. hereby notifies you that any or all communications with this Site can and will be monitored, captured, and recorded and the communications may be transmitted to the authorities as deemed necessary by BravoEd Inc. in its sole discretion and without further notice.
11. **User Content Terms.** All content generated by a Registered User, must comply with local, national, provincial, state, and federal privacy legislation and best practices. Identifying information must be removed from Registered User Content. In addition, You must refer to the Content Policy herein and you represent and warrant that each time you submit content you have complied with the terms therein on what identifying information should be removed from images of people.
12. **Ownership of Content.** BravoEd Inc. does not claim ownership of any Content that you post on or through the Service. Instead, you hereby grant to BravoEd Inc., in perpetuity, a non-exclusive, fully paid and royalty-free, transferable, sub-licensable (through several tiers), worldwide license to use, reproduce, view, communicate to the public by any means, print, copy, (whether onto hard disk or other media), edit,

translate, perform, and display (publicly or otherwise), redistribute, modify, adapt, make, sell, offer to sell, transmit, distribute, license, transfer, stream, broadcast, create derivative works from, and otherwise use and exploit the Content that you post on or through the Service, subject to the Service's Privacy Policy. If you submit content to BravoEd, you are authorizing BravoEd to act as your agent to issue take-down notices under the Digital Millennium Copyright Act (the "DMCA") and/or any other similar legislation that allows the submission of requests to Internet Service Providers for the purpose of removing infringing or allegedly infringing materials. You will be responsible for monitoring and enforcing your copyright. If BravoEd does become aware of infringement, then BravoEd, at its sole discretion, may elect to issue take-down notices under the DMCA or similar legislation.

13. **User Content Warranties.** You acknowledge and agree that you are solely responsible for all Registered User Content that you make available through the Site, Services, or App. Accordingly, you represent and warrant that: (i) you either are the sole and exclusive owner of all Registered User Content that you make available through the Site, Services, or App or you have all rights, licenses, consents and releases that are necessary to grant to BravoEd Inc. the rights in such Registered User Content, as contemplated under these Terms; and (ii) neither the Registered User Content nor your posting, uploading, publication, submission, or transmittal of the Registered User Content or BravoEd Inc.'s use of the Registered User Content (or any portion thereof) on, through or by means of the Site, Services, or App will (a) infringe, misappropriate, or violate a third party's patent, copyright, trademark, trade secret, moral rights, or other intellectual property rights, or rights of publicity or privacy, or (b) result in the violation of any applicable law or regulation, including, but not limited to any applicable laws, rules, or regulations relating to personal health information, personal information and privacy, the Health Insurance Portability and Accountability Act (HIPAA), the Personal Information Protection and Electronic Documents Act (PIPEDA), the Personal Health Information Protection Act (PHIPA), the Health Information Technology for Economic and Clinical Health (HITECH) Act, the Data Protection Act 1998, the Protection of Personal Information Act 2013, the Data Protection Act of 1978, and any other applicable National, Provincial, State, and Federal privacy laws (collectively, the "Privacy Laws") depending on your country or jurisdiction of access to the App. You retain the sole responsibility of your individual compliance with applicable laws.
14. **Patient Data and Legal Compliance.** National, Provincial, State, and Federal laws, as well as ethical and licensure requirements of your profession and health regulatory college and licensing requirements impose obligations with respect to protection of privacy and patient confidentiality that may limit the ability of dentists, dental healthcare providers, and persons acting on their behalf, to make use of certain confidential patient information ("Patient Information") and/or to transmit Patient Information to third parties without express consent. You represent and warrant that you will, at all times, comply with all laws directly or indirectly applicable to you that may now or hereafter govern the gathering, use, transmission, processing, receipt, reporting, disclosure, maintenance, and storage of Patient Information, and require all persons or entities under your direction or control to comply with such laws, including the Privacy Laws and the Privacy Policy. You are at all times solely responsible for obtaining and maintaining all patient consents, if applicable, and all other legally necessary consents or permissions required or advisable to disclose, process, retrieve, transmit, and view the Patient Information that you transmit, store, or receive in connection with the Site, Services, App, and any third-party site. BRAVOED EXPRESSLY DOES NOT ASSUME

ANY RESPONSIBILITY FOR YOUR USE OR MISUSE OF PATIENT INFORMATION OR OTHER INFORMATION, WHETHER INTENTIONAL OR INADVERTENT, THAT IS TRANSMITTED, MONITORED, STORED OR RECEIVED WHILE USING THE SITE, SERVICES, APP OR COLLECTIVE CONTENT. WE RESERVE THE RIGHT TO AMEND OR DELETE ANY COLLECTIVE CONTENT (ALONG WITH THE RIGHT TO REVOKE ANY MEMBERSHIP OR RESTRICT ACCESS TO THE SITE, SERVICES, APP OR COLLECTIVE CONTENT) THAT WE DETERMINE IN OUR SOLE DISCRETION VIOLATES THE ABOVE. WE FURTHER DO NOT ASSUME ANY RESPONSIBILITY TO MAKE ANY DETERMINATIONS REGARDING YOUR SUBSEQUENT REPORTING OR NOTIFICATION OBLIGATIONS ARISING FROM ANY USE OR MISUSE OF PATIENT INFORMATION OR OTHER INFORMATION; THESE DETERMINATIONS AND YOUR ACTIONS IN RESPONSE TO SUCH DETERMINATIONS REMAIN YOUR SOLE RESPONSIBILITY. YOUR REPRESENTATIONS, WARRANTIES, AND OBLIGATIONS IN THIS SECTION SURVIVE TERMINATION OF THESE TERMS.

15. **NO DIAGNOSTIC SERVICE.** BRAVOED DDS IS PRIMARILY AN DENTAL EDUCATION AWARENESS TOOL AND IS NOT INTENDED TO SERVE THE FOLLOWING NEEDS: AS A DIAGNOSTIC DENTAL SERVICE; AS A CONFIRMATORY SERVICE TO PROVIDE CERTAINTY IN DENTAL DIAGNOSIS; TO SELECT, GUIDE, OR PROMOTE THERAPY OF DENTAL CONDITIONS; FOR USE IN HAZARDOUS OR MISSION-CRITICAL DENTAL CIRCUMSTANCES OR FOR USES REQUIRING FAIL-SAFE PERFORMANCE; OR IN SITUATIONS WHERE FAILURE COULD LEAD TO DEATH OR PERSONAL INJURY (COLLECTIVELY, "UNAUTHORIZED PURPOSES"). BECAUSE BRAVOED DDS HAS NOT BEEN DESIGNED, INTENDED, OR AUTHORIZED FOR SUCH UNAUTHORIZED PURPOSES, YOU SHALL NOT USE THE SITE, SERVICES, OR APP FOR SUCH PURPOSES OR UNDER SUCH CIRCUMSTANCES. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE APP AND ANY SERVICES PERFORMED OR PROVIDED BY THE APP ARE PROVIDED "AS IS" AND "AS AVAILABLE", WITH ALL FAULTS AND WITHOUT WARRANTY OF ANY KIND, AND BRAVOED HEREBY DISCLAIMS ALL WARRANTIES AND CONDITIONS WITH RESPECT TO THE APP AND ANY SERVICES, EITHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY, OF SATISFACTORY QUALITY, OF FITNESS FOR A PARTICULAR PURPOSE, OF ACCURACY, OF QUIET ENJOYMENT, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS. BRAVOED DOES NOT WARRANT AGAINST INTERFERENCE WITH YOUR ENJOYMENT OF THE APP, THAT THE FUNCTIONS CONTAINED IN, OR SERVICES PERFORMED OR PROVIDED BY, THE APP WILL MEET YOUR REQUIREMENTS, THAT THE OPERATION OF THE APP OR SERVICES WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT DEFECTS IN THE APP OR SERVICES WILL BE CORRECTED. NO ORAL OR WRITTEN INFORMATION GIVEN BY BRAVOED SHALL CREATE A WARRANTY. SHOULD THE APP OR SERVICES PROVE DEFECTIVE, YOU ASSUME THE ENTIRE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION. “SERVICE PROVIDERS”) BE LIABLE TO YOU OR ANY THIRD PARTY FOR PERSONAL INJURY, OR ANY DIRECT, INCIDENTAL, SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF PROFITS, LOSS OF DATA, LOSS OF USE, BUSINESS INTERRUPTION OR ANY OTHER DAMAGES OR LOSSES, ARISING OUT OF OR RELATED TO PRODUCT LIABILITY CLAIMS, ANY CLAIM THAT THE APP FAILS TO CONFORM TO ANY APPLICABLE LEGAL OR REGULATORY REQUIREMENT, CLAIMS ARISING UNDER CONSUMER PROTECTION OR SIMILAR LEGISLATION, YOUR USE OR INABILITY TO USE THE APP, OR FOR ANY CLAIM BY ANY OTHER PARTY, INCLUDING WITHOUT LIMITATION, PERFORMANCE OR NON PERFORMANCE OF THE APP, LOSS OF USE, LOSS OF DATA HOWEVER CAUSED, REGARDLESS OF THE THEORY OF LIABILITY (INCLUDING BREACH OF CONTRACT, TORT OR OTHERWISE) AND EVEN IF BRAVOED OR ITS SERVICE PROVIDERS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, RESULTING FROM: (A) THIS AGREEMENT OR THE USE OF, OR THE INABILITY TO USE, THE APP; (B) UNAUTHORIZED ACCESS TO OR ALTERATION OF YOUR TRANSMISSION OR DATA, (C) RELIANCE ON CONTENT OR INFORMATION, OR (D) ANY OTHER MATTER RELATING TO THIS AGREEMENT, THE APP OR THE CONTENT. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OF LIABILITY FOR PERSONAL INJURY, OR OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THIS LIMITATION MAY NOT APPLY TO YOU. The foregoing limitations will apply even if the above stated remedy fails of its essential purpose.

18. **Indemnity.** You agree to defend, indemnify, and hold BravoEd Inc., its officers, directors, employees and agents, harmless from and against any claims, liabilities, damages, losses, and expenses, proceedings or demands including, without limitation, reasonable legal and accounting fees, arising out of or in any way connected with your access to or use of the Site, Services, App, or Collective Content, or your violation of these Terms.
19. **Restrictions.** You may not rent, lease, lend, sell, redistribute or sublicense the App. You may not copy (except as expressly permitted by this Agreement), decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the App, any Updates, or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law). Any attempt to do so is a violation of BravoEd's rights and if You breach this restriction, BravoEd may pursue damages against You.
20. **Advertisements:** You acknowledge and agree that some of the Site, Services, or App may be supported by advertising revenue and may contain advertisements or promotions. If you elect to have any personal, professional or business dealings with anyone whose products or services may be advertised on the Site, Services, or App, you acknowledge and agree that such dealings are solely between you and such advertiser and you further acknowledge and agree that BravoEd Inc. shall not have any responsibility or liability for any losses or damages that you may incur as a result of such dealings. Your representations, warranties, and obligations in this section survive termination of these Terms.
21. **Governing Law.** Except as provided in the addenda applicable to your specific jurisdiction provided with the Terms and except where mandatory law supersedes this choice of law clause, these Terms shall be governed by the laws of the Province of Ontario and the laws of Canada applicable therein. Subject to Section 26 requiring mandatory arbitration of disputes, the courts of the Province of Ontario shall have exclusive jurisdiction to entertain any action arising under these Terms or any other agreement, document, or instrument contemplated herein which cannot be resolved by arbitration or where the enforcement of

an arbitral award requires it, and you hereby accept and irrevocably submit to the jurisdiction of the courts of Ontario and acknowledge their competence and agree to be bound by any judgment thereof. Notwithstanding the governance of these Terms, you may have additional obligations and responsibilities to adhere to in the jurisdiction in which you practice dentistry or another dental profession.

22. **Export and Use Restrictions.** By downloading and using the App, You represent and warrant that You are not (i) located in, under the control of, or a national or a resident of any country that is subject to a U.S. Government embargo, or that has been designated by the U.S. Government as a “terrorist supporting” country; and (ii) listed on any U.S. government list of prohibited or restricted parties.
23. **Apple Terms and Conditions.** You acknowledge and agree that Apple Inc. (“Apple”) is not a party to this Agreement and is not responsible for the App and that the additional provisions in this Section 12 apply to Your use of the iOS operating system version of the App. You may only use the App on an iOS device that You own or control and subject to the Usage Rules set forth in the App Store Terms and Conditions. Apple is not providing any warranty for the App and is not responsible for maintenance or other support services for the App. Any inquiries or complaints relating to the use of the App, including those pertaining to intellectual property rights, must be directed to: mobile@bravoed.com.

Our online privacy statement

Your privacy is important to us. We want you to understand how we safeguard your personal information and what types of information we receive and collect when you visit our websites or download our App.

Personal information and online security

When you visit BravoEd website/App, you are anonymous unless you choose to identify yourself. You are not required to provide personal information to use our website/App, unless a feature requires it. For example, if you have an account with us and wish to access your account online, you will need to provide identifying information referred to collectively as your "Personal User Information." In these cases, we have electronic and procedural safeguards in place to help protect your online personal information from unauthorized use or improper access. These safeguards include:

Passwords: Clients can access their account information online only after providing identifying information and a password. This information is unique to you, and is an important first step in protecting your information online.

Although we have electronic and procedural safeguards that we believe are adequate to protect personal information, any such systems may be subject to human and operational error. In particular, because the Internet is an open system, we cannot and do not guarantee that personal information entered by you online will not be misappropriated, intercepted, modified, deleted or used by others.

We limit access to your information to authorized employees and contractors who need to know that information in order to operate, develop or improve the Application. Please be aware that, although we will take reasonable steps to safeguard and maintain security of Personal User Information, User-Provided Dental Case Information, and Automatically Collected Information that we process and maintain, no security system can prevent all potential security breaches.

You are solely responsible for (1) maintaining the strict confidentiality of your Personal User Information, (2) not allowing another person to use your Personal User Information to access the Services, (3) any and all damages or losses that may be incurred or suffered as a result of any activities that occur under your Personal User Information. You agree to immediately notify BravoEd Inc. in writing by email to info@bravoed.com of any unauthorized use of your Personal User Information or any other breach of security. BravoEd Inc. is not and shall not be liable for any harm arising from or relating to the theft of your Personal User Information, your disclosure of your Personal User Information, or the use of your Personal User Information by another person or entity.

User-provided dental case information

(a) When you use BravoEd DDS application, you may submit a dental-related question by completing the form provided. With signed consent from your patient, you may upload images with your dental question, or comment

on posted dental questions from other users. Your submission will be curated by BravoEd and your dental question to your peers will be posted to the Application.

We will store your uploaded images and question submitted as connected with your personal user information. We do not store IP addresses relating to images uploaded by users.

(b) When you use the application, you may provide comments. We will display and store your comments, the date and time of comments and the username connected to the comments.

(c) When you use the application, you may "favorite" entries for easy reference later. We will store which entries on BravoEd DDS you have "favorited," as well as the date favorited and the username connected to the entry favorited.

Online data collection tools: Improving and evaluating website and app functionality and effectiveness

BravoEd, like many organizations, sometimes gathers data, such as your IP address, regarding how visitors explore our websites/App— information about the number of new and repeat visitors, where on the website/App a visitor explores, how long they visit, where they are geographically located and similar details. We may also track how many users visit advertisements promoting our products and services that appear on other company websites/App. All such information is collected in an unidentifiable form and is used to improve our websites'/App's performance and functionality, create a better experience for our visitors, measure the response to marketing campaigns and provide you with more relevant content based on your possible interests in BravoEd content, products and services.

BravoEd or its agents on our behalf collect this information through the use of cookies and electronic images known as web beacons.

What are cookies and web beacons?

A cookie is a small piece of information that a website sends to your computer where it is stored on your hard drive. The next time you visit our website, we may use the information stored on your cookie to make your visit easier. A cookie does not tell us your identity unless you have chosen to provide it to us. Cookies cannot access other information or files from your computer. There are 2 types of cookies— session cookies and permanent or persistent cookies.

A session cookie (sometimes called a "transient" cookie) is erased when you close your Internet browser and leave our website. In the United Kingdom, only session cookies are used.

A "permanent" cookie is a file that remains on your computer when you close your Internet browser. A permanent cookie can be read only by the website that created the cookie when you revisit that site. Permanent cookies are not used in all of our jurisdictions.

Cookies can identify a visitor only if the visitor has used a website's login feature. If you ask us to save your access ID to be used the next time you visit our website, we will use a permanent cookie to store your access ID in an encrypted format on your computer so that the next time you visit the website you will be recognized when you sign in. In this way, the website can recall your preferences and provide a more customized experience.

Permanent cookies have expiry dates and are automatically deleted from your computer after their expiry date. You can also clear your stored cookies via your browser preferences on your computer. However, unless you have settings that disallow cookies, the next time you visit our website, a new cookie will be added. You can set your website browser to notify you when you receive a cookie so that you can decide whether to accept or reject it. Since the procedure for altering preferences varies by browser you should check the "Help" menu of your browser to learn how to alter your cookie preferences. Please note, however, that rejecting cookies while visiting the BravoEd website may result in certain parts of the website not functioning correctly or as efficiently as if cookies were allowed.

The permanent cookies that may be placed on your computer by the Google Display Network relating to web marketing campaigns are used to increase the relevance of display ads you may see when you visit other websites that are serviced by the Google Display Network. To opt out of these cookies, select the opt out button on the Google Privacy Centre page.

Web beacons are a collective term used to refer to "pixel tags", "web beacons" or "clear GIF images" embedded in a web page and usually invisible to the user. Web beacons are used for many of the same purposes as cookies, allowing BravoEd or its agents on behalf of BravoEd to compile aggregate statistics about website usage patterns, such as how many times a link or an area on a website is clicked.

All the information collected by any of these online tracking tools is non-personal and is not used in connection with any other information that could identify you personally unless you have entered your access ID and password or provided it to us through your permanent cookie.

We may share the site visit information obtained using cookies, web beacons and other similar technologies with Google Analytics or other agents to analyze online activity on our websites or in reaction to our online advertisements.

At this time, BravoEd does not alter its behaviour or change its services upon receiving Do Not Track requests, as described in California Assembly Bill 370.

Do third parties see and/or have access to information obtained by the Application?

We will disclose User Provided and Automatically Collected Information, within or outside your jurisdiction, as described above in the following circumstances:

- as required by law, such as to comply with a subpoena, or similar legal process;

- when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- with our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement;
- if BravoEd Inc. is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of this information, as well as any choices you may have regarding this information; and
- we disclose user email addresses to third party email service providers in order to deliver users BravoEd informational, service and content emails.

What are my opt-out rights?

You can stop all collection of information by easily uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

However, the Application will not allow you to opt out of any announcements and messages related to the implementation of this Policy and your obligations thereunder. As such, should your uploaded images, image captions, or comments contain identifying information about a patient, you will receive messages from BravoEd Inc. notifying you of a potential privacy violation associated with this content.

You may also delete your account by going to your profile and tapping the settings button top right. You will be asked to confirm that you would like to delete your account. If you confirm, your profile information will be automatically deleted from the host server. Your images and comments will not be automatically deleted from BravoEd DDS. You may request to have all images and comments associated with your account deleted. However, we cannot guarantee that we will be able to recall and delete all images and comments that have been posted.

Changes to Privacy Policy

This Privacy Policy may be updated from time to time for any reason. Each time you use the Application, the most current version of the Privacy Policy will apply. We will notify you of any changes to our Privacy Policy by posting the new Privacy Policy here. You are advised to consult this Privacy Policy regularly for any changes. Unless stated otherwise, the most current version of the Privacy Policy applies to all information that we have about you. We will not materially change our policies and practices to make them less protective of your privacy without the consent of affected users.

Links to websites outside of BravoEd

To provide website/App visitors with more information that may be helpful to them, our website/App may contain links to other websites that are not affiliated with or maintained by BravoEd. We do not monitor the privacy

practices of these third-party sites, and do not have authority over them. As a result, we do not assume any responsibility for the data collection policies and procedures of these sites.

Surveys & Contests

From time-to-time our site requests information via surveys or contests. Participation in these surveys or contests is completely voluntary and you may choose whether or not to participate and therefore disclose this information. Information requested may include contact information (such as name and shipping address), and demographic information (such as zip code, age level). Contact information will be used to notify the winners and award prizes. Survey information will be used for purposes of monitoring or improving the use and satisfaction of BravoEd website/App.

Collection of personal information from children

BravoEd website/App is not directed at children and does not knowingly collect information from children under the age of 18.

Your Consent

By using the Services, you are consenting to our processing of Personal User Information, User-Provided Dental Case Information, Optional User Provided Information, Automatically Collected Information as set forth in this Privacy Policy now and as amended by us. "Processing" means using cookies on a computer/hand held device or using or touching information in any way, including, but not limited to, collecting, storing, deleting, using, combining, and disclosing information.

We will make every effort to investigate and respond to your complaint in a timely way.
